WEEKLY ELECTRICITY MARKET ANALYSIS AUSTRALIAN ENERGY REGULATOR

13 May - 19 May 2012

Summary

The average weekly spot price ranged from \$25/MWh in Queensland and Victoria to \$34/MWh in Tasmania.

Spot market prices

Figure 1 sets out the volume weighted average (VWA) prices for the week 13 May to 19 May and the 11/12 financial year to date (YTD) across the NEM. It compares these prices with price outcomes from the previous week and year to date respectively.

Financial markets

Figures 2 to 9 show futures contract² prices traded on the Australian Securities Exchange (ASX) as at close of trade on Monday 21 May 2012. Figure 2 shows the base futures contract prices for the next three calendar years, and the average over these three years. Also shown are percentage changes³ from the previous week.

Futures contracts traded on the ASX are listed by d-cyphaTrade (www.d-cyphatrade.com.au). A futures contract is typically for one MW of electrical energy per hour based on a fixed load profile. A base load profile is defined as the base load period from midnight to midnight Monday to Sunday over the duration of the contract quarter. A peak load profile is defined as the peak-period from 7 am to 10 pm Monday to Friday (excluding Public holidays) over the duration of the contract quarter.


Figure 3: \$300 cap contract prices (\$/MWh)

Figure 4: Number of exchange traded contracts per week






Figure 5: Quarterly base future prices Q2 2012 - Q2 2016

Figure 7: New South Wales Q1 2010, 2011, 2012 and 2013




Figure 8: Victoria 2010, 2011, 2012 and 2013





Figure 9: South Australia Q1 2010, 2011, 2012 and 2013

Spot market forecasting variations

The AER is required under the National Electricity Rules to determine whether there is a significant variation between the forecast spot price published by the Australian Energy Market Operator (AEMO) and the actual spot price and, if there is a variation, state why the AER considers the significant price variation occurred. It is not unusual for there to be significant variations as demand forecasts vary and as participants react to changing market conditions. There were 33 trading intervals throughout the week where actual prices varied significantly from forecasts⁵. This compares to the weekly average in 2011 of 78 counts and the average in 2010 of 57. Reasons for these variances are summarised in Figure 10⁶.

⁶ The table summarises (as a percentage) the number of times when the actual price differs significantly from the forecast price four or 12 hours ahead and the major reason for that variation. The reasons are classified as availability (which means that there is a change in the total quantity or price offered for generation), demand forecast inaccuracy, changes to network capability or as a combination of factors (when there is not one dominant reason). An instance where both four and 12 hour ahead forecasts differ significantly from the actual price will be counted as two variations.

Demand and bidding patterns

The AER reviews demand, network limitations and generator bidding as part of its market monitoring to better understand the drivers behind price variations. Figure 11 shows the weekly change in total available capacity at various price levels during peak periods⁷. For example, in Queensland 329 MW more capacity was offered at prices under \$20/MWh this week compared to the previous week. Also included is the change in average demand during peak periods, for comparison.


Ancillary services market

The total cost of frequency control ancillary services (FCAS) on the mainland for the week was \$291 000 or less than one per cent of energy turnover on the mainland.

The total cost of FCAS in Tasmania for the week was \$110 000 or less than two per cent of energy turnover in Tasmania.

Figure 12 shows the daily breakdown of cost for each FCAS for the NEM.
