



Figure 1: Changes in regulated revenue over time

Figure 2: Changes in total revenue between 2019–24 period




Figure 1: Changes in regulated revenue over time

AER holds a public forum	5 April 2023
Submissions on regulatory proposals close	12 May 2023
AER publishes draft determination decision	28 September 2023
AER holds a pre-determination conference	October 2023
TasNetworks submits revised regulatory proposal to AER	30 November 2023
Submissions on revised regulatory proposals and draft decision close	by 19 January 2024
AER publishes TasNetworks transmission and distribution determination for regulatory control period	by 30 April 2024
