Overview

Section 1 below sets out specific sections of the supporting materials and models that make up Jemena Electricity Networks (Vic) Ltd.'s (**JEN's**) application to the Australian Energy Regulator (**AER**) to reopen its current electricity distribution price determination covering the regulatory control period between 1 July 2021 and 30 June 2026 (current regulatory period) for a capital expenditure variation event, that JEN claims to be confidential and the basis of the claim. JEN has applied the rationale for claiming information as confidential as set out in the AER's confidentiality guideline.¹

JEN has provided reasons detailing how and why disclosure of the information would cause detriment to the business or to our customers. JEN understands that this confidential information being available to the AER to perform its functions under the rules provides a public benefit. JEN has assessed that, in all identified cases, JEN's confidentiality reasons, together with the benefits already realised through the AER's confidential use of this data, are not outweighed by any additional public benefit to disclosure of the information.

JEN has marked confidential information in documents by highlighting the content in yellow text [____]. It has not been possible to highlight all diagrams or elements included as pictures in documents. In these instances, JEN has made it clear in section 1 that the relevant item is subject to a confidentiality claim.

2. **Proportion of confidential information**
