I. WELCOME AND CONFLICTS OF INTEREST

II. PANEL LEAD UPDATE (NO UPDATES THIS MEETING)

III. AUSNET ITEMS (SLIDES PROVIDED)

- A. Quantifying Customer Value
- i. As this was a "deep dive" AusNet have recorded the notes and actions for this item
- B. Offsite August 2024
 - i. CE noted the objective of the offsite is to come away with the narrative for the draft proposal and confidence that the numbers are reflective of customer preferences. Will circle back with CG in about a month's time to discuss agenda, format and attendees of the offsite in more detail.
- C. Engagement on resilience
- i. CE outlined the extensive engagement with customers and with government processes (e.g. Network Outage Panel) following February storms. AusNet will submit a resilience plan to the Victorian regulator before presenting to the AER. Planning to run some deliberative forums, and will seek CG input to those, but current thinking is that more 1-1 customer interviews not required at this stage. However AusNet noted that it was the CG's decision on which further interviews would be undertaken and how the remaining budget was utilised.

- i. No new engagement/research to report on, but Helen has a call set up this afternoon with a community group and there's a meeting on the 17th to review the research program.

- i. AER offered to take questions, but there was nothing specific to report.

- i. DP updated the group on CCP's network engagement now that Robyn and Mark had been added to the Vic resets panel. He also noted that since their budget for 24/25 had not been finalized the panel had yet to work out how to allocate their time across the networks.
