## ACCEPTANCE OF BUSHFIRE MITIGATION PLAN UNDER THE ELECTRICITY SAFETY ACT 1998 (VIC)

We refer to the Bushfire Mitigation Plan version 10.2 dated 16 October 2023 (**BMP**) submitted by Powercor Australia Limited (ACN:064 651 109) to Energy Safe Victoria pursuant to Part 10, Division 2A of the *Electricity Safety Act* 1998 (Vic) (**Electricity Safety Act**). The documents comprising the BMP are listed in **Attachment A**.

Pursuant to section 83BE(2) of the Electricity Safety Act (as applied by section 113C), Energy Safe accepts the BMP.

Energy Safe takes this opportunity to remind Powercor Australia Limited that:

- Powercor Australia Limited must comply with the BMP;
- Powercor Australia Limited must submit a revised BMP to Energy Safe if any of the circumstances in section 107 of the Electricity Safety Act apply or no later than five years from the date of this letter, whichever comes first;
- Energy Safe may at any time request submission of a revised BMP;
- Energy Safe expects that Powercor Australia Limited will comply with the general duties under section 98 of the Electricity Safety Act.
