Purpose AusNet provided an overview of the engagement activities to date.		
AusNet MD Presentation and Q&A AusNet's Managing Director, Tony Narvaez, thanked stakeholders for their contributions to AusNet's Revenue Proposal. Tony referenced the many changes and challenges that AusNet's transmission network is facing (including that the operating environment is highly changeable and fast- moving), and that it is a whole of industry effort to maintain a secure, reliable and affordable system throughout. Tony said that AusNet's proposal relies heavily on cost pass-throughs where costs cannot be accurately estimated, to help ensure customers are not paying more than they need to.	 The issues raised by stakeholders included: the collegiality in the networks industry at present the string of unlucky events AusNet has faced over the past few years the need for improved governance on many matters that impact AusNet's network and network costs (e.g. transparency of government transmission planning processes, REZs, big battery projects etc). Stakeholders said they want clear communication on how much projects and decisions cost, where risk lies, the costs to consumers, and the value that these investments provide the industry the lack of transparency around the VicGrid initiative, Moorabool battery project and ISP projects the Victorian Government's easement tax and stakeholders' desire for AusNet to not become an intermediary for state taxes, and the relationship and delineation of responsibilities between AusNet and AEMO, and whether AusNet should assume planning and implementation responsibilities for Victoria. 	
Re-cap of engagement process and collaborative workshops AusNet and KPMG provided an overview of the topics discussed and stakeholder views on them. How AusNet's Revised Proposal reflects customer and stakeholder feedback AusNet demonstrated how stakeholder input on capex and opex has been reflected in its Revised Proposal. AusNet provided a detailed	Stakeholders were asked to confirm that AusNet has interpreted their inputs correctly and felt these views had been accurately reflected in the Revised Proposal. Many stakeholders indicated their agreement and AusNet stressed that it welcomes further feedback at any stage in the lead-up to its Revised Proposal being lodged. Stakeholders agreed that AusNet's summary of Collaborate Workshop #5 accurately reflected the discussion.	AusNet accepted all stakeholder comments. Nothing contentious or new was raised in this session.
re-cap of the opex workshop (Collaborative Workshop #5).	Stakeholder discussion included:	



AusNet shared its analysis on the impacts of the Revised Proposal on bills. AusNet highlighted that as residential and some small business customers consume more of their own energy, an increasing proportion of the transmission costs are being met by large customers.

- clarification on TUOS, NUOS and DUOS charges, and that these (particularly TUOS) need to be more transparent
- supporting comments from CCP members that incentive schemes need to be reviewed (while protecting consumers' interests), and
- the importance of retaining transmission productivity in a complex operating environment.

Close & Next Steps

AusNet asked for feedback on its post-lodgement engagement program to date (particularly the collaborative workshops), which is summarised at right.

AusNet thanked:

- participants for their extremely valuable input and time
- the AER's CCP
- AEMO for contributing to relevant discussions, and
- KPMG for their support administering the workshop series.

Stakeholder Feedback

Stakeholders were very complimentary of AusNet's postlodgement engagement program during the workshop. Stakeholders praised:

- AusNet's openness and honesty during the post-lodgement engagement program
- AusNet's willingness to be challenged and asked hard questions
- AusNet focusing its engagement on the topics that are important to stakeholders, even when they might not be directly relevant to the regulatory process.

Stakeholders have been asked to provide AusNet with further feedback via a survey that will be distributed soon.

AusNet reiterated that it welcomes stakeholder input and feedback at any time as it prepares it Revised Proposal. Once AusNet has submitted its Revised Proposal, there will be an opportunity to provide further input during the AER's engagement process.
