Essential Energy's 2023-24 Pricing Proposal

I am pleased to provide Essential Energy's 2023-24 Pricing Proposal (Pricing Proposal) to the Australian Energy Regulator (AER) and advise that it complies with the terms of the AER's 2019-24 Final Determination for Essential Energy ("the Determination").

The Pricing Proposal has been prepared in accordance with the requirements of Chapter 6 of the National Electricity Rules (the Rules) which establishes a process of price notification and review by the AER for annual price changes. The Pricing Proposal also follows the structures detailed in the Determination – Tariff Structure Statement (TSS). The Pricing Proposal adheres to the Indicative Pricing Schedule contained in the TSS for 2023-24 and has only been updated for:

- CPI:
- > Cost of Debt and resulting change to Weighted Average Cost of Capital and X factor;
- Pass through of Transmission Use of System charges advised by TransGrid, Powerlink and various distributors;
- > Pass through of jurisdictional scheme amounts including the new NSW Electricity Infrastructure Roadmap charges; and
- > Adjustments to revenue as required under the Rules.

In preparing this Pricing Proposal, Essential Energy has utilised a customer, consumption and demand forecast developed for our upcoming regulatory proposal. This forecast methodology has been outlined in the attached Pricing Report for 2023-24 and in more detail as an attachment to this pricing proposal. Please note that as previously advised during the Preliminary Pricing engagement process, the consumption forecasts have been updated for Site Specific customers to reflect the latest information available.

In addition, the Pricing Proposal provides more detail on our proposed tariff trials. As indicated in a letter to AER dated 28 February 2023, Essential Energy intend to conduct further tariff trials during the 2023-24 year and the proposed tariff structures for trial have been included.

2023-24 Pricing Proposal Key Points:

- Essential Energy is proposing an overall nominal increase in average prices for network services of 7.52 per cent;
- The change in revenue to be recovered is proposed to be an increase of 6.57 per cent;
- The increase in prices for network services is driven by:
 - Inflation (CPI) increase of 7.83 per cent;

- o Adjustments for the forecast under recovery of DUoS revenue in prior years;
- o Adjustments for the forecast under recovery of TUoS revenue in prior years;
- Adjustments for the Service Target Performance Incentive Scheme;
- o Inclusion of recovery of Retailer of Last Resort events; and
- Inclusion of the recovery of costs associated with the implementation of the NSW Electricity Infrastructure Roadmap.
- These increases are partially offset by:
 - Decreases in real DUoS charges of 3.08 per cent;
 - Decreases in TUoS charges from TransGrid and Powerlink; and
 - Adjustments for the forecast over recovery of Climate Change Fund revenue in prior years.
