JEMENA ELECTRICITY NETWORKS (VIC) LTD 2014 PRICING PROPOSAL

Dear Mr Reeves

In accordance with the requirements of clause 6.18.2(a)(2) of the National Electricity Rules (**NER**), Jemena Electricity Networks VIC Ltd (**JEN**) submits its proposed 2014 distribution, transmission, jurisdictional scheme, alternative control and public lighting tariffs for approval.

This letter and accompanying documents constitute JEN's 2014 pricing proposal. The 2014 Pricing Proposal submission includes the following seven files:

1. JEN's 2014 pricing proposal (Confidential and Public versions)
2. JEN's 2014 pricing proposal Attachment 1 (Confidential) - JEN's 2014 tariff model — This is the Australian Energy Regulator's (**AER's**) excel model containing all the necessary data to demonstrate JEN's compliance with the AER's 2011-15 price determination
3. JEN's 2014 pricing proposal Attachment 2 (Public) – JEN's proposed 2014 tariff schedule — JEN's 2014 tariffs schedule to be placed on the AER's and JEN's website once the tariffs are approved
4. JEN's 2014 pricing proposal Attachment 3 (Confidential) – JEN's 2014 public lighting tariff excel model
5. JEN's 2014 pricing proposal Attachment 4 – JEN's 2014 fee based services model
6. Confidentiality statement – consistent with the AER's confidentiality guideline JEN provides a confidentiality statement that details each confidentiality claim we submit with the proposal

Note, in its 2014 pricing proposal JEN is proposing to make the following changes:

1. **Removal of tariffs 'Large Business - LV - LVEN 6.0+ GWh' and 'Large Business - HV - HVEN 10+ GWh'** – these two tariffs were introduced in 2007 and they were not taken up by any customer. As a result these tariffs were removed from Attachment 1, Tabs "Prop2014DistTar", "2014DistTarRebalCont", "Prop2014PassThroughTar", "Prop2014TransTar", "Prop2014JSTar".
2. **Changes to the tariff name and tariff criteria of associated with the current tariffs Large Business - LV_{EN} 2.2 – 6.0 GWh and Large Business - HV – HV_{EN}**

Annual Consumption <=10 GWh – due to the removal of the two tariffs mention in the previous dot point it became necessary to change the tariff name and tariff criteria of tariffs Large Business - LV_{EN} 2.2 – 6.0 GWh and Large Business - HV – HV_{EN} Annual Consumption <=10 GWh to ensure all possible consumption profiles of embedded network customers are covered within JEN's tariff structures. The explanation on how these changes comply with the NER is outlined in the JEN's 2014 Pricing proposal section 4.5.1. The changes made are summarised in the table below:

Large Business – LV_{EN} 2.2 – 6.0 GWh

For the purpose of completing Attachment 1, Tab "Prop2014DistTar" we have used the new tariff names in column B, heading "Proposed tariff" and the old tariff names in column C, heading "Existing tariff". However, this should not be considered as introducing new tariffs.
