JEMENA ELECTRICITY NETWORKS (VIC) LTD 2022-23 PRICING PROPOSAL

In accordance with the requirements of clause 6.18.2(a)(2) of the National Electricity Rules (**NER**), Jemena Electricity Networks VIC Ltd (**JEN**) is pleased to submit its pricing proposal for 2022-23. The pricing proposal covers distribution, transmission, jurisdictional scheme, alternative control and public lighting tariffs.

This letter and accompanying documents constitute JEN's 2022-23 pricing proposal. Our proposed 2022-23 prices are based on our proposal to bank our service target performance incentive scheme reward outcome from 2020 and the first half of 2021 via the s-bank mechanism.¹ Should the AER not approve Jemena's proposed s-factor banking, then this will necessarily impact the 2022-23 prices as the reward outcome will need to be added back into the total 2022-23 allowed revenue.
