**Proposed amendments to the Access Arrangement and Access Arrangement Information for the Dawson Valley Pipeline**

We refer to your email of 2 May 2007 and our teleconference of 3 May 2007.

We confirm that the Service Providers are prepared to make the following proposed amendments:

- (a) in relation to 3. Reference tariff method, proposed amendments 1 and 2;
- (b) in relation to 7. Reference tariffs, proposed amendments 1, 2 and 3;
- (c) in relation to 8. Non-tariff elements, proposed amendments 1, 2, 3, 5, 6, 7 and 9; and
- (d) in relation to 9. Key performance indicators and access arrangement information, proposed amendments 1 and 2.

In relation to 8. Non-tariff elements, proposed amendment 4, we confirm that we are prepared to make the proposed amendment with the addition of the following:

*' the reasonable costs of any testing of the metering facilities requested by the User are to be paid by the User unless the facilities are found to be faulty in which event Anglo Coal will pay the costs of testing'.*

Set out below is our suggested wording in relation to 8. Non-tariff elements, proposed amendment 5:

*'The current MAOP of the DVP is limited to approximately 11.5 – 12 MPag. The MAOP is constrained by the design pressure of the discharge pulsation bottles and the design pressure of the discharge coolers on the existing compressors at both the Dawson and Moura compression stations. Both the discharge pulsation bottles and the discharge*

*coolers have a design pressure of 12750 kPag. To operate the DVP at 14.6 MPag, both the compressors and the TEG units would need to be replaced.'*

In relation to 8. Non-tariff elements, proposed amendment 8, we confirm that the Service Providers are happy to remove the reference to '*above 30TJ/day*' and replace it with '*above current capacity*'.

We are in the process of drafting the proposed amendments to the Access Arrangement Information. We hope to be able to provide the draft amendments to you shortly.
