1 Confidentiality template

The confidentiality guideline¹ sets out how energy network businesses must make confidentiality claims over submitted information. The guideline balances protecting genuinely confidential information with ensuring that stakeholders can access sufficient information on issues affecting their interests. It aims to make the process for claiming confidentiality clear and consistent, and to provide greater certainty on how confidentiality claims are assessed.

Table 1 summarises the confidential information TasNetworks has provided as part of its 2023-24 annual pricing proposal.
